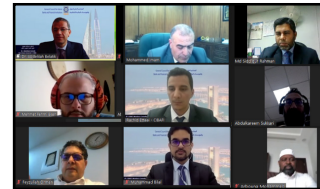

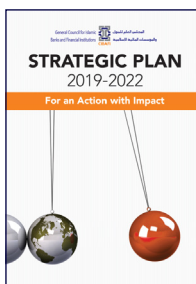

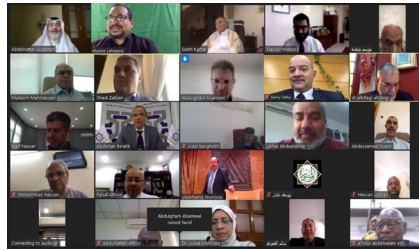
### CIBAFI Award 2021 Ceremony "Adoption of Financial Technologies (Fintech)"
